- Hotels/Motels.....\$210 + \$5 per unit
- Financial Institutions.....\$550 + \$20 per million dollars of deposits in Fayetteville
- Real Estate Companies.....1-4 agents=\$275; 5-9 agents=\$550; 10-19 agents=\$825; 20 or more agents=\$1,100 (Real Estate Agents can join the Chamber as an individual professional listing for \$100 if their company is a member.
- Professionals.....\$275 first professional \$50 each additional professional (Doctors offices, law firms, accounting firms and insurance agents)

A one-time processing fee of \$40 will be added to each new membership investment total. Membership will renew annually unless written notice is submitted. Investment is tax-deductible as an ordinary and necessary business expense, but is not a charitable deduction.
